MBBS Year 1-3



(Integrated System-based Medical Curriculum)

- PHES: Health & Society (Year 1- 3)
- Content (1st semester) similar to "Foundations of Public Health" in:
 - --General Education requirement for medical students
 - --BSc Public Health (PBH 1001) minor in public health & general education to all University Students

Covers: Health systems, law & ethics, global health, social aspects of health & infectious diseases related to public health



MBBS Year 1-3



(Integrated System-based Medical Curriculum)

- Life Long Learning Skills (Year 1- 3)
- Evidence based Medicine (Epidemiology & biostatistics in year with other departments)
 - Lecture and workshops



MBBS Year 2 - 3



- COSK (Communication Skills) & PCLM (Clinical Methods): By FM clinical teachers
- Family Follow up Projects (Public Health & FM)
- Self Selected Module (SSM): By FM & PH colleagues



MBBS Year 4



- 9 weeks of teaching on Family Medicine & Community Medicine (Public Health Medicine)
 - Family Medicine: focused on the individual health with 6 key learning outcomes/competencies
 - Teaching methods: Community clinical attachments, case-based tutorials, role play consultations, self video taped discussion
 - Community Medicine/Public Health Medicine: focused on population health
 - Teaching methods: Lecture (epidemiology, evidence based medicine etc.) & case exercises, community/public health visits: Health Protection Agency, Occupational health (occupational health clinics), Department of Health Clinics
